Dear Mister Chairman,

During the XLIX COSAC meeting the current Permanent Member of the COSAC Secretariat, Mrs Libby Kurien, announced that she would not seek reappointment.

In this context, I am grateful to be able to present my application for the post of Permanent Member of the COSAC Secretariat.

My first element of motivation is my close relationship with COSAC. Indeed, from 1 January 2010 until 30 June 2011 I was a member of the COSAC Secretariat. During that period I had the opportunity of learning a great deal about the practical organization and *modus operandi* of the Secretariat. From 1 July 2011, I have been present at every meeting of the COSAC Conference (Chairpersons and Plenary). Both these experiences gave me a particularly valuable insight into the "back office" as well as into the "front office" of the Conference.

Secondly, my membership of the IPEX Board and Central Support has enabled me to see what interparliamentary co-operation really implies. Indeed, genuine co-operation has got more to do with discussing and negotiating than with imposing rules.

The third element of my motivation is my background in the Committee Department of the Belgian House of Representatives where, for almost a decade, I have been the Clerk of the Special Committee accompanying the Standing Police Monitoring Committee. As this committee sometimes handles extremely sensitive documents and reports regarding the Belgian law enforcement agencies, it is one of the last Committees of the House which still meets in camera. The experience I gathered in this field has taught me to draft concise yet clear reports.

The linguistic element of the post should not be an obstacle when one takes into account that I graduated as a master in translation (English – Spanish) on the one hand and that, being an official of a federal Belgian legislative assembly, I am officially bilingual (Dutch – French) on the other hand.

For further elements of my biography, I kindly refer to my curriculum vitae I enclose herewith.

I sincerely hope that these elements will convince you that I make a good candidate for the post of Permanent Member of the COSAC Secretariat.
