## Dear Chairmen,

I would like to express my interest in the position of the Permanent Member of the COSAC secretariat. I believe that my experience and education make me an ideal candidate for this position.

As my résumé indicates, I have roughly 13 years of professional experience in the European Affairs in the Chancellery of the Sejm. I have been following developments in the COSAC conference since 1998.
