Co-financing of the permanent member of the COSAC Secretariat and the costs of running the office and website of COSAC

National parliaments have committed themselves to co-financing the permanent member of the COSAC Secretariat and the costs of running the office and website of COSAC for different periods of time. In most cases, the commitments will expire at the end of 2009. Therefore, the issue of continued co-financing from 1 January 2010 needs to be dealt with as soon as possible. This note sets out the present situation and some possible solutions.

The Conclusions of the XXXVI COSAC in Helsinki on 20-21 November 2006 state that a majority of national parliaments had expressed a will to contribute to the expenses incurred by the national parliament sending an official to the post of the permanent member of the COSAC Secretariat from January 2008.

At the COSAC Chairpersons' meeting in Berlin on 11 February 2007 national parliaments were asked to send signed letters of intent to the Presidency indicating their willingness to contribute towards co-financing the next permanent member of the COSAC Secretariat. The letters of intent were collected by the following four COSAC Presidencies: German, Portuguese, Slovenian and French.

The amended Rules of Procedure of COSAC, published in the Official Journal of the European Union on 31 January 2008, provide that the cost of seconding the permanent member of the COSAC Secretariat to Brussels and other necessary technical costs of the Secretariat are jointly borne by those Parliaments wishing to contribute. The amount and terms of payment for the co-financed expenditure are defined in an agreement between the participating parliaments².

As of September 2008, all national parliaments have indicated their willingness to take part in the co-financing of the permanent member of the COSAC Secretariat and the costs of running the office and website of COSAC. Out of 27 national parliaments, 19 national parliaments accepted the co-financing conditions recommended in the Report of the Working Group on co-financing of the permanent member of the COSAC Secretariat presented to the XXXVI COSAC meeting in Helsinki.

More specifically, 19 national parliaments agreed to participate in the co-financing from 1 **January 2008 until 31 December 2009** provided that at least 13 other Member States make a similar commitment, the maximum expenditure is € 80,000 per year and the maximum contribution of one national parliament does not exceed € 5,714.29 per year³.

2 national parliaments committed themselves to co-financing from 1 January 2009, while 1 national parliament committed itself from 1 January 2008 until 31 January 2009. 5 national parliaments and 2 chambers agreed to participate in the co-financing until 31 December 2010, while 3 national parliaments did not specify the final term of their commitment (see Table on p. 4-8).

Consequently, the incurred, approved and audited expenses of the permanent member of the COSAC Secretariat and the costs of running the office and website of COSAC in the years 2008-2009 will be divided as follows:

- in 2008, between 25 national parliaments;
- in 2009, between 26 national parliaments, except the expenses incurred in January 2009, which will be divided among 27 national parliaments.

The *Seimas* of the Republic of Lithuania seconded an official, Ms. Loreta Raulinaitytė, to serve as the permanent member of the COSAC Secretariat for the period from 15 April 2008 to 18 February 2010⁴.

According to the request expressed in letters of intent from the participating parliaments, after the end of the year to which the contribution refers, i.e. at the beginning of 2009, the Lithuanian *Seimas* will present a report of its approved expenditure for maintaining the permanent member of the COSAC Secretariat and the costs of running the office and the website of COSAC (i.e. from 15 April 2008 until 31 December 2008) to the national parliaments. It will also certify that the expenditure has been accounted and audited according to the rules of the *Seimas*. This report will be provided with the request for payment.

The commitment of the majority of national parliaments to participate in the co-financing **expires on 31 December 2009.** It is therefore important that COSAC decides on the future of the co-financing this year, preferably during the COSAC Chairpersons' meeting in Stockholm in July 2009. Since the two-year term in office of the current permanent member ends on **18 February 2010**, the XLII COSAC in Stockholm will have to appoint the next permanent member of the COSAC Secretariat. Therefore it is important that the amount and terms of payment for the co-financing of the expenditure are defined during the Swedish Presidency.

One possible solution would be to invite national parliaments to send to the COSAC Presidency a **new letter of intent**, specifying a new commitment period or leaving it open. Another solution would be to **sign an agreement** provided for in the COSAC Rules of Procedure. A third solution could involve participating parliaments **transferring** to the national parliament seconding its official to the post of the permanent member of the COSAC Secretariat their yearly **contributions before the start of the year** with any unused amounts being carried over to the next year (as the arrangement for co-financing the IPEX information officer). This final option would be easier for the national parliament seconding its official than the present one.
